Invitation and brief summary:

Thanks for your interest in this research. This is for an evaluation of the Local Climate Adaptation Tool. We want to better understand your positive and negative experience of using the tool and the impact it is, or might have, on your work.

Please take time to consider the information carefully and to discuss it with family or friends if you wish, or to ask the researcher questions.

Why have I been approached?

You have been approached because you either:

- expressed an interest to us in taking part in this research
- your colleague suggested that you might be interested in taking part in this research

This research is specifically interested in talking with people using LCAT as part of their job or professional role. The research will not be talking to members of the public using LCAT for personal use.

What would taking part involve?

We will ask you questions about:

- Your use of the tool
- The impact the tool might be having on your work, or might have in the future
- The barriers and opportunities that you might have faced in advancing climate adaptation work
- You and your work such as type of organisation

All questions are optional.

The 1-2-1 interview (I1) will take around 1 hour to complete. Our team will work with you to find a time and date that works for you and it will take place on Microsoft Teams.

What will we talk about? The interview is an informal chat between a researcher and you using topics as prompts. It provides an opportunity to discuss your use of LCAT, your experience and feedback, the impact that it has had or might have in the future and the barriers you and your organisation might have faced in terms of taking action on climate adaptation. We will also ask some questions about your role and your organisation.

Can I see the questions ahead of the interview? Yes, we will share the topic prompts ahead so you can begin thinking about the answers. However, it is completely fine not to have read it ahead.

How long will it take? The interview will take around 60 minutes to complete.

Where will it take place? The 1-2-1 interviews will take place online, using Teams. This will be scheduled at a time and date that suits you. It will be within working hours.

Will it be recorded? Yes, the interview will be video and audio recorded. You have the option to switch your video off. Field notes will be made using Microsoft Word. Files will be used for transcription. Once transcripts have been completed, we will delete the video recordings.

Data collection:

Will everything be stored securely? Yes. All recordings, notes and transcripts will be stored securely on University of Exeter's secure Sharepoint platform. If you provided your email address within a questionnaire, this will be stored securely. At the point we start to analyse your results, email addresses will be transferred to a password protected document and de-linked from the results. Thereafter we will use a non-identifiable code for your results which anonymises them.

With your permission, we will video record the 1-2-1 interview using Microsoft Teams. You can turn off your camera. The video recording will be stored immediately on the secure University SharePoint Platform and deleted from any original device. A professional transcription company will be provided with anonymised files for transcription. Recordings of interviews will be permanently deleted once transcribed and checked for accuracy.

We will employ a transcription company who complies with the following measures to ensure confidentiality: 1) Non-Disclosure Agreement; 2) staff transcribers contracts including strict confidentiality and data protection clauses; 3) password protection and encryption on files; 4) secure servers; 5) staff transcribers ID vetted.

What information are you collecting?

- Your feedback on your experience of using LCAT, information about your role and workplace and the impact it has had via a 1-2-1 interview, recorded, via Microsoft Teams.
- Your email address, if you have opted into or expressed an interest in taking part in this research.

Can I be anonymous?

Yes. When we publish or promote any results/ conclusions, all participants will be anonymised. When we use a direct quote, this too will be anonymised, for example, 'participant 1 said: "I do like it" and by removing any identifiable information such as place names and names of organisations.

However, during the process of collecting your questionnaire/ interview data, your email address (that you have provided us with) will be initially linked to your results. To process the data and anonymise your results ready for analysis, we will:

- Once the transcription process is complete, the Teams recordings will be deleted.
- The email you have provided us with will be put in a separate, password protected document.
- Transcripts and field notes will be coded with a non-identifiable code.

Any identifiable documents/ recordings will **not** be shared publicly nor published. They will be stored securely using the University of Exeter's secure Sharepoint platform online storage.

Why are you collecting this information?

- To improve LCAT and support the development of future versions of LCAT
- To understand the wider context within which you work, the barriers to taking action on climate adaptation and learnings that might benefit future users
- To understand the impact that LCAT has had on you, your work, your organisation and local area
- To showcase the use of LCAT (via PR, case studies, events and promotion) and the benefits that it might bring to future users

What are the possible benefits of taking part?

We cannot promise specific personal benefits.

What are the possible disadvantages and risks of taking part?

We do not believe that taking part in the research has any foreseeable risks to participants. The minor disadvantage of taking part is our request for your time.

What will happen if I don't want to carry on with the study?

At any time, the following documents can be deleted at your request:

- Contact information (e.g., email address)
- Recordings from interviews, field notes, transcriptions

Withdrawing when analysis of the results has begun and thereafter:

- If analysis has already proceeded, we cannot remove your feedback from documents produced as part of the analysis or results. This is because we cannot separate out your specific feedback at this point of the process since it has been amalgamated with other people's feedback. Furthermore, by the point of analysis, we will be using anonymised data (i.e., we cannot identify you at that point as we will have separated any identifiable data e.g., email address from your feedback).

How will my information be kept confidential?

Your data will be treated in complete confidence. Names, contact details and other identifiable information are only available to the research team. Researchers will generate an anonymous number and assign to your name. This number will be used in reporting the findings. The link between your name and the anonymous number will exist as an electronic file only. It will be stored in a separate directory to all other data, which is only accessible by selected research team members.

Personal information we will use in this project is:

- Information about you, including your area of work, type of job you do and the sector you work within;
- Your experience of using the Local Climate Adaptation Tool, the impact it has had and barriers to taking action on climate adaptation.

The consent forms that include your name will be stored electronically, separately from all other information.

All electronic data will be stored on password-protected computers, password-protected external storage devices, or storage systems approved for research data by the University of Exeter. Any paper records will be shredded before disposal and online records and documents will be deleted and removed from the 'Trash', on or before end Sept 2031.

Making data publicly available

This project is publicly funded. It is therefore a requirement that a fully anonymised version of the data be publicly available so that they can be used in related ongoing research. This dataset may be made available for other researchers to use in a fully anonymised form, so that the information cannot be linked to you and your identity will not be revealed. The following information would be made publicly available:

- Data from interviews. This includes:
 - Anonymised demographics (type of job, area of work, sector of work);
 - Your experience of using the Local Climate Adaptation Tool, the impact it has had and barriers to taking action on climate adaptation.

You can still take part, even if you do not want your anonymised data shared in this way. We will ask for your consent via the accompanying consent form.

For interview transcripts: After the interviews and analysis have been conducted, and if we feel that redacted transcripts can be safely shared, we will ask you to check the redacted transcripts to confirm you are happy for the documents to be made more widely available. You are under no pressure to consent. If permission is not granted, they will not be shared.

The University of Exeter processes personal data for the purposes of carrying out research in the public interest. The University will endeavour to be transparent about its processing of your personal data and this information sheet should provide a clear explanation of this.
